## **JOB OVERVIEW**

This position is a full-time exempt employee role, reporting directly to the Executive Director. The VINE Program Manager (PM) is responsible for managing all aspects of the VINE program in Colorado.



## This will include:

- Provide training and education on the program to new and potential users such as victim advocates, peace officers, district attorneys, etc. Communicates changes or new product information as needed.
- Promote awareness of VINE program through community outreach efforts at conferences, presentations and educational booths and displays.
- Establishes agency personnel access to VINE secure websites and manages user needs, questions, and training.
- Coordinates contracts and agreements with the system provider, Appriss.
- Works with the Executive Director to procure and manage funds for the VINE program.
- Provides quarterly reporting of performance metrics to the Colorado Division of Justice.
- Tracks VINE program expenses and income ensuring adherence to budget and proper and consistent recording within the accounting system.
- Manages grants and other funding sources, providing required reporting, tracking and payments.
- Manages VINE website and social media accounts, providing updated information and resources for users and potential partners.

## **EXPERIENCE:**

The ideal candidate will have experience in planning and delivering adult training programs, supporting system upgrades, and coordinating with vendors, volunteers and users of programs. Requirements Include:

- Ability to collaborate effectively across organizations for the purpose of providing high quality outreach and training programs to a variety of audiences throughout the state.
- Understanding of the Colorado Crime Victim Rights Act (VRA) to understand the functionality needed for VINE.
- Proficient in MS Office (Word, Excel, Power Point).
- Aptitude to develop, recommend, and implement new initiatives to increase the effectiveness and influence of VINE within the community.
- Capacity to communicate effectively to all customers of CSOC and VINE while maintaining confidentiality.
- Adept in time management, organization skills, and planning and execution of quality programs within budget.
- Capable of working independently, taking responsibility for program outcomes and growth.
- Willingness to travel to deliver trainings and attend conferences throughout the state.
- Have a valid driver license, ability to meet driving standards, reliable transportation, and proof
  of insurance.
- Previous law enforcement experience preferred, but not necessary.
